

GUARANTEE OF RAPICIDE® PA AND RAPISPOR HLD COMPATIBILITY WITH FLEXIBLE ENDOSCOPES

MEDIVATORS® RAPICIDE® PA and RAPISPOR® High-Level Disinfectant (HLD), when used as directed in a MEDIVATORS® ADVANTAGE PLUS®, ADVANTAGE PLUS® Pass-Thru, DSD EDGE® or RAPIDAER® automated endoscope reprocessor, is compatible with flexible endoscopes marketed by the following manufacturers: Fujifilm Corporation, Olympus Corporation, Hoya Corporation, Karl Storz Endoscopy, Welch Allyn and Richard Wolf Medical Instruments.

Based upon MEDIVATORS extensive battery of pre-market testing and validation protocols, we are quite confident that RAPICIDE PA and RAPISPOR peracetic-acid based HLD will not only provide for the high-level disinfection of flexible endoscopes, but also will not damage endoscopes (when used as directed). Accordingly we offer the following guarantee:

If your endoscope is damaged as a result of the proper use of RAPICIDE PA HLD or RAPISPOR HLD in the ADVANTAGE PLUS, ADVANTAGE PLUS Pass-Thru, DSD EDGE or RAPIDAER endoscope reprocessor, we will pay the full cost of repair for any damage verified to be caused by exposure to RAPICIDE PA or RAPISPOR HLD.

After initial inspection of your current scope inventory, and the subsequent use of RAPICIDE PA or RAPISPOR HLD in an ADVANTAGE PLUS, ADVANTAGE PLUS Pass-Thru, DSD EDGE or RAPIDAER automated endoscope reprocessor as described above, should any of your pre-inspected flexible endoscopes be functionally or physically damaged (excluding normal cosmetic wear and tear) during the proper use of the disinfectant and reprocessor, MEDIVATORS will pay the full cost for the repair of the damaged endoscope, as described below.

Any claims for flexible endoscope damage relating to the use of RAPICIDE PA or RAPISPOR HLD with a MEDIVATORS endoscope reprocessor must be reported to MEDIVATORS within two business days following detection of the damage. A complaint record will be opened for the incident at that time.

Assessment of the reprocessor and/or disinfectant-related damage to an endoscope will be conducted by a qualified independent firm or individual that provides inspection and repair of flexible endoscopes. Should such assessment determine that the use of RAPICIDE PA or RAPISPOR HLD in a MEDIVATORS reprocessor (when properly used per manufacturer's instructions) has indeed caused functional or physical damage to the endoscope, Medivators Inc. will pay the cost of repairs to the endoscope that are specifically caused by and related to the use of the MEDIVATORS reprocessor, RAPICIDE PA and RAPISPOR HLD.

MEDIVATORS reserves the right to modify or withdraw this guarantee with 90 days' prior notification.
